

PRIVACY POLICY

In accordance with Article 13 para. 1 and para. 2 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons in regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC (Official Journal of the European Union L. 2016.119.1), General Data Protection Regulation, hereinafter referred to as "GDPR", I inform that:

GENERAL INFORMATION

DATA SECURITY

- 3) In the interests of the security of data entrusted to us, we have developed internal procedures and recommendations to prevent disclosure of data to unauthorized persons. We control their implementation and constantly check their compliance with relevant legal acts - the Act on the protection of personal data, the Act on the provision of electronic services, as well as all kinds of executive acts and Community law.
- 4) Personal Data is processed on the basis of the consent expressed by the User and in cases where the law authorizes the Administrator to process personal data on the basis of the law or for the purpose of implementing a contract concluded between the parties.

METHOD OF DATA COLLECTION

PURPOSE OF DATA COLLECTION

PERIOD OF PERSONAL DATA STORAGE

Personal data processed based on the Administrator's legitimate interest will be stored for the duration of the contract for the period necessary to:

- fulfilling the Administrator's legal obligation (e.g. resulting from tax or accounting regulations)
- personal data processed based on a separate consent will be stored until its revocation

SALE OF PERSONAL DATA

- 6) Personal data left on the site will not be sold or made available to third parties in accordance with the provisions of the Act on the protection of personal data.

ACCESS TO PERSONAL DATA

- 7) The data contained in the form is available for inspection by the natural person who placed them there. This person also has the right to modify and stop processing his data at any time. If you
